## **NEW PROJECTS**

#### **JSAFE**

JSAFE started in January 2018 with the following goals 1) support judges to pronounce informed decision sentencing on cases of radicalisation at all stages of the procedures through the use of the most appropriate risk assessment tools, also with the support of 'Legal Expert of the Court for Radicalisation Assessments'; 2) Support prison and probation staff in the execution of sentences through a coherent set of programmes and an integrated flow of information, parallel to ECRIS, among multilevel and multiagency stakeholders Activities: WS1:Research and European Technical Platform to Assess Risks:WS2:Handbooks, Guidelines and Policy Recommendations; WS3: European Resource Centre and Legal Experts of The Court for Radicalisation Assessments; WS4: Dissemination.

#### **SATLAW**

SATLAW started in August 2018 with the following goals 10bjectives: Contribute to a bi-annual case-based report (art.37) to the EC on the application of Directive 2104/41/EU on the basis of both qualitative and quantitative information, including the coherence, harmonization and interrelation with other judicial instruments to harmonize judicial and police cooperation.



## **NEW PROJECTS**

#### **MIICT**

MIICT started in November 2018 and was conceived with the goal of designing, developing and deploying tools that address the challenge of migrant integration through the co-creation of improved ICT-enabled services with migrants, public sector services and NGOs.

#### **PROPHETS**

PROPHETS started in May 2018 with the goal of redefining new methods to prevent, investigate and mitigate cybercriminal behaviours through the development of a coherent, EU-wide, adaptive SECURITY MODEL, built upon the interplay of the human factors within the new cyber ecosystem and capable of addressing the four fundamental dimensions at the core of the phenomenon: 1. early identification of security threats; 2. investigations within a new publicprivate governance; 3. Increased complexity of the response due to the expansion of the security perimeter towards new societal fields and the emergence of challenging jurisdictional problems; and, last but not least, 4. perception of security and freedoms among citizens, which requires a new communication strategy for LEAs and security policy makers.

TRAINING AID will end in April 2019. 90% of its activities are successfully concluded, including a Toolkit for European Professionals in the field of countering radicalization, training courses in 26 countries and over 2000 users in the HERMES platform.



TAKEDOWN will end on September 2019. Agenfor's activities have been successfully concluded and approved by the Donor.



MINDB4ACT will end in September 2020. Agenfor has been taking part in WP2 activities and will take the leadership of WP5 during 2019.
