**Duration:** 2-day event

Format: Hybrid – Closed list of participants on site and conference streaming for the public audience

Participants: 50-80 attendees in presence, 100 online attendees.

**Event format:** The event comprises four different formats:

- 1. Public Conferences: held in presence and streamed online. Relevant investigative and judiciary cases will be discussed in 3 ½ hours of seminars. Speakers and selected key stakeholders will attend the seminars on site, while a broader range of stakeholders and the wider public will be able to access the event online via live stream. Strict health and hygiene measures will be taken to prevent the potential spread of Covid-19 and to ensure the event can be held as planned.
- 2. Closed-door Roundtable: held in presence and streamed online. Two assigned minute-takers will compile a report of the Roundtable which will be circulated among the attendees before being disseminated to European experts.
- 3. Parallel events and Publication Stands: In parallel to the conferences, Virtual Reality courses, and roundtables, there will be small events and stands presenting product demonstrations, short training sessions, and the distribution of relevant printed publications, at which the attendees will have the chance to enter into discussion with the authors.
- 4. Tech demonstrations and exhibition: In parallel to conferences, an exhibition will be hosted to present state-of-the-art technologies, platforms and modern training solutions for justice and police practitioners.

09:00 – 13:10 FIRST SESSION - PUBLIC CONFERENCE: NEW INVESTIGATIVE MODELS FOR THB IN THE FRAMEWORK OF PUBLIC-PRIVATE COOPERATION (FAIRNESS, UNCHAINED and BIG OSINT)

THB (trafficking in human beings) is a serious crime that abuses individual's fundamental rights and dignity. THB can take various forms and typically involve, one way or the other, illegal migration, sexual exploitation (incl. exploitation of prostitution), forced labour, frauds and fake documents, money laundering and corruption, among other associated crimes. While criminal networks move across borders - through countries of origin, transit and destination – investigating and prosecuting crimes becomes the competence of each of the Member States crossed, each according to their fragmented jurisdictions. Cross-border cases of trafficking in human beings are difficult to investigate as they require resources, coordination and good communication between relevant authorities and civil society organisation. In the Triveneto territory new models are emerging, that could represent a Best Practice for Europe. According to a recent report from Save the Children, one in three trafficking victims is a minor. Trafficking, mafias, exploitation of human beings, especially of minors, are phenomena that are complex to bring to light in an ever-changing context. In this respect, the Fairness project has developed a series of Communities of Practices in five different countries, with the aim of contributing to the alignment of national strategies for the full implementation of the Stockholm Roadmap. A specific focus consisted in the identification of Italian and EU best practices to fight new emerging phenomena, characterised by a mix of different crimes, including terrorist and mafia crimes (poycrimes). Particular attention was devoted to restorative justice, applied in particular in Italy in the juvenile context.

# NAVIGATING THE COMPLEXITIES OF JUDICIAL COOPERATION INSTRUMENTS (SAT-LAW, TREIO, PRE-TRIAD and PRE RIGHTS)

Legal cases such as 'Enchrochat' and 'Sky ECC' pose several legal and doctrinal questions, with a view to the developing jurisprudence of national and European Courts for what concerns Special Investigative Techniques, EU judicial cooperation, transfer of evidences and data protection and privacy in the digital era. Moreover, prosecutors often have to use multiple instruments at the same time or in sequence for the same transnational investigation, even if these are not always congruent. This Panel offers an understanding on the complex relation between technological evolutions and law in a fragmented Europe and how judicial training could contribute to foster a shared judicial culture.
