# **DESCRIPTION OF THE PROCUREMENT PROCEDURES**

Considering that Agenfor International is a private foundation, recognized by public authorities and accredited by the EU, the tender rules will be organized in line with their procurement procedure, using a transparent methodology to collect offers and select services, as defined in the project description approved by the EC.

**GENERAL PROJECT RULE**: The services describe in BIG OSINT and STAND-UP are awarded by a facilitated open procedure in which the procurement notice:

- (1) Is published in Italy through the project website, via Agenfor International open space and eventually in local newspapers, AND
- (2) The managing body of the project draws up a selection list of service providers, suppliers and contractors from which the managing board selects the candidates of its choice. The candidates are sent a letter of invitation (or a legal mail) to tender, explaining the references of such tender procedures (publication, reference, country, contracting authority and type of contract), accompanied by a tender dossier (or reach the Project Management at the official address and by no later than the date and time shown in the letter of invitation to tender to submit their tenders).
- (3) For both projects, service contracts and supply contracts per lot below 75.000,00 and with a performance period of under 36 months, can be assigned directly in line with the Law Decree 76/2020 as commented by the MIMS interpretation n,764 dated 20.102020. While service contract for a higher value must be awarded under a competitive negotiated procedure or simplified procedure, involving at least five valid candidates, meaning that least five competitive contractors must be consulted.

Tenders must reach the Project Management at the official address and by no later than the date and time shown in the letter of invitation to tender to submit their tenders.

Based upon the list of the selected company, a negotiation with the awarded tenderer will take place to eventually further reduce the price in line with the budget approved by the EC. In case tenderers selected in the procedure refuse the contract, the other bidders will be selected in their order, selecting the second best price/quality ratio.

Within the framework of the Eu-funded project BIGOSINT, coordinated by the Prosecutor Office of Trento, the consortium is needs to acquire the following specialized services that are not available in the MEPA platform.

#### TENDER LOT 1 - Max 65.000€

#### PREMISE:

2 years rental of a new version of the FAST platform with new interface, modules and data integration, to gather, elaborate, correlate and equalize data from the main closed and open databases in Europe, producing searchable investigative files from OSINT (open source) and deep Web (closed data).

The new 2 modules of the FAST platform must have the capacity to import structured and unstructured files from different closed sources such as National DBs used by LEAs and EU agencies, bank and money transfers, residences, phones, property, company and vehicle registers but also open source data and Deep Web analysis with the possibility to correlate all types of data adding several analytical possibilities, including "entities", "events" and "correlation" visualized in different forms (link charts, geo -referential maps connected to entities and space-time events, data prioritization, etc.) producing also financial equalizations for all entities in ration to the events and risk indicators.

The licenses consist in a Data-based intelligence software platform, on premises or browser, with the capacity to import structured and unstructured files from different sources (national DBs such as the Italian SDI; highway transits; driver licenses and vehicles registers; banks financial transactions; business company registers (like Italian Telemaco, imported data from OSINT source) and similar DBs; real estate property, fiscal and tax registers, electronic billing, access IP log on cloud services, phone calls analysis, including ID spoofing calls, interceptions and digital forensics extractions). The platform should allow the user to edit and perform entity-detection on textual content and to archive any kind of multimedia content. The platform provides the capability to crosscheck structured data with unstructured data (manual import) adding several analytical possibilities, including correlated analysis of entities, link charts, geo-referential maps connected to entities and space-time events and financial transactions, with financial equalization.

The conditional call for offer concerns 5 full licenses for Italy and 2 test licenses for Spain and Germany through strong authentication (user and password connected to a Token OTP) and full independent management.

Installation and services: 5 full licenses for 5 contemporary investigations must be installed in Italy, under the Coordination of the Prosecutor Office of Trento, and 2 test licenses must be installed by the German and Spanish partner for testing purposes.

#### CLOUD:

2 years rental of a tech tool for downloading, parsing, crawling and archiving of deepweb pages and integrated into a tool for cryptocurrency monitoring and blockchain analytics. The solution must be adaptive for crypto currency explorations to link deepweb and soft chain analysis with real-life events while decoding and parsing both human-readable and machine-produced contents integrated with anti-CAPTCHA solutions and hooking methods to pass authentication and authorization credentials.

LOT3: 2 years rental for an OSINT platform adaptive to the FAST Importer, with data normalization, using API for Twitter and indexed open contents for all other social media, including a multilingual semantic engine.
