JANUARY - FEBRUARY 2023

TRUST

Second Steering Committee, Rome 11 January 2023

The Second SC was held on the 11th of January 2023 in Rome at CeSi's premises, moderated by CeSI's Project Coordinator. Agenfor, FADV, ActionAid, Trento's Prosecutor Office, Carabinieri, ABD, COREIS participated in presence, while CESIE ETS connected via Microsoft Teams. During the meeting, the achievements as well as the pending issues of WP2 and WP3 were discussed by WP leaders (CeSI and FADV). Moreover, the working plan of WP4 was presented by CESIE ETS and the consortium discussed the cities were implementing the activities foreseen for the next stage of the project. Besides the presentation delivered by the partners, Prof. Luigi Manconi, a member of the Advisory Board, addressed the consortium online for sharing his comment on the results achieved by the project so far.

PRE-AND-POST

Steering Committee, Rimini 20 January 2023

In a remarkable event in Rimini in the chambers of the Bar Association in the Tribunal, magistrates, lawyers, probation officers, and other experts of the judiciary field met to start the PRE-AND-POST EU-co-funded project, delineating the priorities and possible challenges to address.

UNCHAINED

Training 2-3-9-10 February 2023

The pilot phase of UNCHAINED demonstrated its pivotal aims during the training sessions held at the beginning of February, improving participants skills in the field of addressing and preventing THB through the use of technologically advanced tools and public-private cooperation.

TRUST

Workshop for Co-design of the Action Plan 8 February 2023

The Co-design Workshop was organised as a full day on 8th February 2023 in Milan by CESIE. A total of 32 participants attended the workshop: 19 participants representing 3 main groups, namely, Law Enforcement Authorities (LEAs) and local authorities, Muslim community and Civil Society Organisations (CSOs) and 12 representatives of the TRUST Consortium. The participants provided feedback on the presented Action Plan and CESIE ETS updated it based on the discussions. At the end of February 2023, CESIE ETS developed a report with information about the organisation and implementation of the workshop (D4.1).

High-Level Seminar, Sofia 21-22 February 2023


Another pivotal step for the HOPE project, a High-Level Seminar organized in Sophia with experts from all over Europe.

STAND-UP

OSINT Webinars, 14-15-20-22 February 2023

Three webinars were organized locally by the Italian, Greek and Spanish project partners, AGF, FUNDEA and EPLO, and a final Pan-European one. The Italian webinar presented the case of antisemitism in Italy, the Greek presented the case of xenophobia in Greece,

the Spanish presented islamophobia in Spain, and the Pan-European one included all these cases. The participants in all webinars were experts, professionals, and stakeholders in hate crime and hate speech, and they came from CSOs, LEAs, academia and government bodies



HOPE

Steering Committee, Belgrade 22-23 March 2023

After the high-level conference of the previous month, the HOPE Consortium met in Serbia to discuss the latest achievements and challenges of the previous months and activities, planning the next steps.

PRE-AND-POST

Pilot, Trieste 30 March 2023

Trieste was chosen to held the beginning of the PRE-AND-POST pilot phase, gathering relevant actors within the judicial sector, namely magistrates, lawyers, and police forces to discuss the issues related to the project and improve the current framework of actions.

REUNION

WP2 April 2023

REUNION partners disseminated the Survey drafted to understand the challenges in implementing Framework Decision 909/2008. The Survey was delivered to practitioners of the judiciary field in the partner countries - Italy, Portugal, Spain, Romania, Poland, Germany - and external countries to maximize the outcomes of WP2.

INTERCEPTED

Steering Committee, Trieste 27 April 2023

The Kick-off meeting of INTERCEPTED was successfully held in Trieste, participated by partners' representatives to delineate the project management plan and possible risks in the implementation of foreseeing actions.

Third Steering Committee, Athens 4 May 2023

On 4 May, the Project Steering Committee Meeting of STAND-UP was hosted at the European Public Law Organization (EPLO) headquarters in Athens, the partners who led this meeting. The topics covered at the meeting were the work packages about

STAND-UP Pilot carried out by TNJudPol (Public Prosecutor's Office at the Ordinary Court of Trento), Dissemination and Communication by FUNDEA, and the Management and coordination of the action and Financial management of the action, covered by TNJudPol.

TPM and 1st TARS, Bruxelles 12-14 June 2023

Fundamental cooperative events for guaranteeing a concerted evolution of the project while fostering transparency and union within the partnership. The TPM provided an open space for partners to gather and discuss the project's progress and ongoing implementations. The TARS engaging relevant European criminal justice practitioners, who will enrich and expand their relations. Magistrates, judges, lawyers, professors,

mediators, researchers, and probation Netherlands, officers from the Austria. Romania, Portugal, France, and Belgium were actively involved in practical case studies and professional presented their experiences in the application alternative measures to detention.



JUNE - JULY 2023

STAND-UP

Training, Italy 21-28-29 June 2023

TRUST

Technical tables, Italy June - July 2023

Collaborative workshops guiding participants in co-designing an action plan for implementing the selected most promising solutions were held in Milan and Trento. The panels saw the presence of the practitioners involved in the previous activities and constituted a fundamental step towards the implementation of the action plan of the project.





BIGOSINT

Two ToTs (Trainer of Trainers) - Murcia, July 12th 2023; Bremen, July 19th 2023

The second and third ToT sessions took place in Murcia (Spain) and in Bremen (Germany) with the aim of further combatting Trafficking in Human Beings (THB) through the use of Big Data and OSINT Analysis. The training has been organised by the Murcia Police, the Euro-Arab Foundation, the Hochschule für Öffentliche Verwaltung Bremen and Agenfor International. Members of the Law Enforcement Agencies from the Netherlands, Israel, Italy and the United Kingdom, Spain and Germany attended the event.

JULY - SEPTEMBER 2023



Prototyping Activities - from September 2023

The initiation of prototyping activities across all the partner countries which will last for 15 weeks, piloted by Murcia Local Police, Prosecution Office of Trento and HFÖV. The technologies of the projects will be stressedtested in real-life environments and through case analysis.

J-CAP

Second TARS (Transnarional Awareness-Raising Symposium) - Paris, September 6th and 7th 2023

The 2nd TARS took place in Paris, France, at the École National de la Magistrature's premises. The Symposium aimed to strengthen cooperative relationships between participants, leading to fruitful exchanges of ideas and practices, and improving knowledge regarding one another's judicial system and competent authorities.



National Roundtables - September and October 2023

These seven national events aimed to transmit conclusions from the symposia to national audiences and, on the other hand, allow for focus points to debate concrete topics stemming from previously held discussions and events, as well as identified needs by practitioners and justice professionals.

PRE AND POST

Fourth and Fifth CoPs (Communities of Practice) - Capo d'Orlando, July 14th 2023 and Milan, September 27th 2023

On July 14th, in Capo d'Orlando (Italy), the fourth CoP, a round table on multi-agency cooperation in the implementation of FD 2008/947/JHA, took place. Italian practitioners discussed on the application of the principle of mutual recognition to judgments and probation decisions with a view to the supervision of probation measures and alternative sanctions, transposed into Italian law by Legislative Decree N.38 of 15 February 2016. The fifth CoP gathered practitioners in Milan on September 27th to discuss Restorative Justice in the light of the Cartabia reform.



14th of July 2023

The study meeting focused on restorative justice as regulated by the recent Legislative Decree no. 150/22, focusing on the future applicability of restorative justice programs at the different stages of the proceedings and highlighting the role of the main actors involved.

OCTOBER - NOVEMBER 2023

TRUST STAND-UP

Dissemination event, Turin 20 October 2023

Agenfor International Foundation presented, with the support of the Municipality of Turin, the joint work of the European projects TRUST and STAND-UP at CTE NEXT, House of Emerging Technologies, a dissemination event on hate phenomena and the public-private cooperation model. Among the speakers, the Councillor Giovanna Pentenero, Municipality Councillor Abdullahi Ahmed, and RAN expert Diletta Berardinelli.





REUNION

National FGs (Focus Groups) for solutions mapping towards offender rehabilitation - September and October 2023



Over the months of September and October, the six national FGs took place in the partner countries (Italy, Germany, Portugal, Spain, Romania, Poland). The Italian FG was held at the Court of Appeal of Venice on September 29th. It was in-depth meeting on the application 2008/909/JHA and 2008/947/JHA, during which the President of the Court of Appeal of Venice Carlo Citterio, the Attorney General at the Court of Appeal of Venice Federico Prato, the Counsellor at the Court of Cassation Debora Tripiccione, the Director General of International Affairs, the Judicial Cooperation at the Ministry of Justice Stefano Opilio, and the former Public Prosecutor at the Court of Lucca Pietro Suchan delivered keynote lectures on the application of European legal instruments.

HOPE

International Conference - Lisbon, November 29th 2023

In a remarkable event in Lisbon, more than 50 experts and decision-makers gathered to discuss radicalisation prevention, foster collaboration and share insights to develop tailored solutions in the scope of preventing and countering violent extremism. To foster a discussion on these issues and present an innovative, holistic approach to face it, the HOPE International Conference, held on November 29th, 2023, brought together participants from 14 countries and five international organisations, such as the Council of Europe, the Organisation for Security and Co-operation in Europe (OSCE), the Confederation of European Probation (CEP), and the International Organisation for Migration (IOM). The diverse audience comprised researchers, law enforcement representatives, policy and programme coordinators, as well as decision-makers from national prison and probation systems.

NOVEMBER - DECEMBER 2023

INTERCEPTED

Focus Gropus (FGs) - Italy, November 10th; Greece, November 21st; Spain, November 30th 2023

The FGs were dedicated to exchange of ideas and practices focusing specifically on advertisement and recruitment in order to effectively intervene to both supply and demand sides of THB (Trafficking in Human-Beings). The events gathered Law Enforcement Agencies (LEAs), Internet Service Providers (ISP), Judicial Practitioners and Victim Protection/Assistance Services to discuss the following topics related to the INTERCEPTED project. Moreover, Public-Private Cooperation Guidelines were released.

TRUST

Dissemination event, Saronno 11 November 2023

A major event was planned at the Islamic Culture Centre in Saronno to initiate a

debate between the police, authorities and the Muslim community on women in Islam and the importance of 'not keeping silent' in the face of crimes and speeches that undermine the right to equality.



STAND-UP

Addressing Hate Crime in the Digital Era Webinar 12 December 2023

A final webinar was organized by the Greek partners to present the outcomes of the project and promote the Policy Brief drafted by GNCHR.

Several relevant actors. namely European stakeholders, researchers, activists working in preventing and tackling the hate phenomena participated in the event.



VR-DigiJUST e-Capsules

The VR-DigiJUST consortium produced short, up to date, tightly blueprints to address

justice professionals' immediate needs in the context of concrete cases and jurisprudential developments at the EU, national and regional levels with an informative and andragogical educational style, sharing information among the network of experts with a cross-sectoral and multidimensional view.


